for educational, research, and academic exchange purposed, aiming at fostering academic excellence, sharing resources, and promoting holistic learning experiences.

Terms of Collaboration:

1. Exchange of Faculties: Both institutions agree to exchange faculty members for short-term visits to each other's campuses. These visits may include delivering lectures, conducting workshops, participating in seminars, and engaging in collaborative research projects.

2. Students Exchange Program: YACPGTRC and Loknete Rajarambapu Patil Ayurvedic Medical College & Hospital, Post Graduate Institute and Research Center, Islampur. will establish students exchange program, allowing students from both institutions to visit each other's campuses for educational purposes, including gaining exposure to different teaching methodologies, clinical practices, and research facilities.

3. Joint Webinars/Seminars: The institutions will organize joint webinars, seminars and conferences on topics of mutual interest. Faculty members and students from both institutions will actively participate in these events, sharing knowledge and insights.

4. Any amendments or modifications to this MoU shall be made in writing and shall be mutually agreed upon by both parties.


Governing Law:
