Memorandum of Understanding (MOU)

This Memorandum of Understanding (MOU) is entered into on this 15th day of January 2025, by and between:

1. **Loknete Rajarambapu Patil Ayurvedic Medical College & Hospital, P.G. Institute & Research Centre, Islampur** (hereinafter referred to as "Party I"), having its registered office at Islampur, Sangli District, Maharashtra.
2. **Sangli Zilla Parishad, Sangli**, including its schools in Urun Islampur (hereinafter referred to as "Party II"), located at:

- Zilla Parishad School No. 1, Islampur
- Zilla Parishad School No. 2, Islampur
- Zilla Parishad School No. 3, Islampur
- Zilla Parishad School No. 4, Islampur
- Zilla Parishad School, Hanuman Nagar, Islampur
- Zilla Parishad School, Ninai Nagar, Islampur
- Zilla Parishad School, Hemantnagar, Islampur

Purpose: The primary purpose of this MOU is to establish a collaborative partnership between Party I and Party II to promote healthcare services, education, training, and health-related initiatives and promotion of Ayurvedic treatment and Panchakarma procedures in the community through effective coordination with the above-mentioned schools.

Terms of the Agreement:

1. **Non-commercial Intent:** Both parties agree that this collaboration is non-commercial in nature and aimed solely at community welfare, education, and healthcare improvement.

2. Responsibilities of Party I:

- Provide healthcare services to students, teaching staff of schools working under Party II.
- Organize health check-up camps, awareness sessions, and educational workshops on topics such as hygiene, nutrition, and preventive care.
- Facilitate Ayurvedic medical services, including free Panchakarma procedures and treatment for children, teachers, and others, as required.
- Offer training and clinical exposure to undergraduate and postgraduate students by conducting these health initiatives.

3. Responsibilities of Party II:

- Provide necessary permissions and logistical support for the smooth implementation of health initiatives by Party I within the schools.
- Ensure cooperation and participation from school staff, students, and their families in the health-related activities.
- Facilitate communication between Party I and the individual branches of the Zilla Parishad schools for proper planning and execution of programs.

4. Joint Responsibilities:

- Both parties will collaborate to create monthly plans for healthcare initiatives and monitor the outcomes to ensure community benefits.
- Parties will mutually decide on schedules for health camps, training sessions, and workshops.

5. Free Services:

- Party I will provide free essential medical treatments, Panchakarma procedures, and health check-ups during health camps organized under this MOU.
- Advanced investigations such as X-rays, CT scan, MRI will be free for all students and teachers.
- Medicine and laboratory blood investigations are payable.

6. Monitoring and Reporting:

- A joint committee will be formed to monitor the implementation of the initiatives and prepare regular progress reports.

7. Duration:

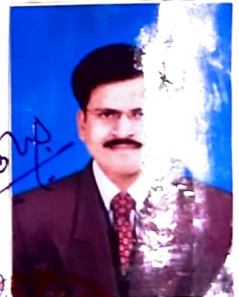
- This MOU shall remain in effect for a period of five (5) years from the date of signing, with an option for renewal upon mutual agreement of both parties.
